"16th INTERNATIONAL AWARDS FOR COOKING WITH EXTRA VIRGIN OLIVE OIL, "Jaén, Inland Paradise" AT THE 33 SALÓN DE GOURMETS 2019

#### BASIC INFORMATION

The Provincial Council of Jaén is announcing the 16th International Awards for Cooking with Extra Virgin Olive Oil, "Jaén, Inland Paradise" at the 33 SALÓN DE GOURMETS 2019. The main aim of this award is to promote the province of Jaén's extra virgin olive oil in the culinary field, stimulating the creativity of national and international chefs.

#### Participants

It is open to all chefs or individuals who work in catering establishments at the time of submitting their application to take part.

#### How to take part

By presenting a recipe that must be prepared using one or more of the oils from the latest "Jaén Selection" tasting competition. The recipe must have been created by the chef.

Only one recipe per chef is allowed.

Registration is free.

#### Documents, place and deadline for submission

The participants' proposals must include the following documents:

1. Application form addressed to the President of the Provincial Council (Appendix I).
2. Photocopy of National Identity Document (DNI) or similar, as applicable, identifying the participant in the award.
3. Document from the catering company certifying that the

individual applying to take part in the award works there.

4. Recipe with which to apply for the award. The recipe must contain the following sections, all written in Spanish:

- Name of dish.
- Name of participant.
- Name of establishment.
- Ingredients.
- The Jaén Selection 2019 oils used.
- Preparation.
- Presentation.
- Utensils used.
- The cooking time should not exceed one hour.

5. A photograph of the finished and presented dish, with a good resolution.

All documents should be submitted to the General Registry of the Provincial Council of Jaén, to any of the registries of its Autonomous Bodies, or through any of the means indicated in Article 16 of Law 39/2015 of 1 October, on the Common Administrative Procedure of the Public Administrations, with the following reference:

The recipe submission period begins upon publication of the official announcement in the Official Provincial Gazette (BOP) and ends on 1 March 2019.

#### Prizes

- Three prizes will be awarded:
- First prize: 8,000 euros and a trophy.
- Second prize: 3,000 euros and runner-up plaque.
- Third prize: 1,000 euros and runner-up plaque.

The prizes will be financed by budget allocation No. 2019.742.4390.48900. The availability of the awards shall depend on adequate and sufficient credit being available when the winner is announced.

The prizes are compatible with whatever other subsidies, benefits, incomes or resources originating from any public administrations or entities, whether public or private, national, or European Union or international bodies that might be awarded to the recipient following the award of these prizes.

#### Dynamics and functioning of the awards

The recipes are selected via a two-stage process.

In the first eliminatory round, all of the applications submitted will be assessed by the Panel of Judges using the following criteria:

1. Recipes must be prepared using the oils selected in the latest Jaén Selection Tasting Competition 2019. The pairing of the olive oil with the ingredients used in the recipe will be assessed.

2. The recipes must be practicable and comprehensible in the view of the Judges.
3. The presentation and originality of the dish, as well as the correct use of all the ingredients in its preparation, will be assessed.
4. The dishes must have been created by the same chefs participating in the competition.

The 12 recipes that will compete in the final will be selected at this stage.

The 12 chefs chosen will take part in the final round. The winner will be chosen based on the flavour, appearance and final taste of the prepared dish.

The final will take place at the Salón de Gourmets, on the Jaén Provincial Council's stage at IFEMA, the Madrid Fair, on Wednesday 10 April 2019 and the culinary demonstrations (preparation) will be done in front of a public audience.

The finalists will have 1 hour to prepare their recipes. They will have no assistants and will have to prepare seven servings, one for each Judge plus one for displaying to the public and the press. The competitors will start cooking at 11 a.m. and will take up their cooking posts at 10-minute intervals.

The order of participation will be decided by a draw and competitors will be notified in advance.

All of the cooking posts will be equipped with a countertop and a cooker with a minimum of two hobs. At the back, there will be a fridge, a sink, a convection oven and a microwave for every two posts. The participants should bring any other equipment, such as work utensils and plates.

The competitors must wear appropriate professional attire: chef whites, dark trousers and appropriate footwear. Their clothing must not bear any inscription, brand, logo or advertising material. Failure to comply will result in automatic disqualification and expulsion from the competition. The organisers will provide an apron with the logos of the competition and its sponsors, which must be worn by the participants. The Judges will also take into account appearance, cleanliness when preparing the dishes and conduct at the stand.

Everything is to be prepared on-site. The chefs are to supply enough raw ingredients to prepare 7 servings, with the exception of the selected oil(s) which will be supplied by the Provincial Council of Jaén.

The Provincial Council will provide return transport from each finalist's place of residence or accommodation in order to take part in the final round. The cost will be covered by credit agreement CO-2016/32, budget allocation 2019.410.9200.22699.

#### **Panels of Judges**

The panel for the first round will be made up of two representatives from the Salón de Gourmets Technical Committee and one representative from the Provincial Council of Jaén.

In the final round the panel will be composed of specialist journalists and renowned chefs, as well as various representatives of the Provincial Council of Jaén.

The panel will be appointed by decision of the President of the Provincial Council of Jaén, and will be published in the Official Provincial Gazette of Jaén a

minimum of 15 days before each round of the competition.

The panels will function in accordance with Article 17 of Law 40/2015, of 1 October, on the Public Sector Legal Regime.

The final panel will submit a proposal for the winner, in accordance with the award criteria contained in this announcement, within 15 days of the final round of the competition. The panel may declare any of these prizes null and void. The panel's decision will be forwarded to the competent body of the Provincial Council of Jaén for the prize to be issued in the month following the submission of the panel's proposal. Under exceptional circumstances, the decision may differ from the panel's proposal. Reasons will be given for the decision made. The decision will be published in the Official Provincial Gazette pursuant to Article 45 of Law 39/2015, of 1 October, on the Common Administrative Procedure of the Public Administrations.

The Council may reserve the right to publish, reproduce, broadcast or record the recipes and photographs via any system, and may sell and release freely, on an exclusive basis and without limitation, the aforementioned rights in favour of any individual or entity, free of charge. To this end, the application to participate implies transferral of the aforementioned rights.

When the winner receives the prize, he or she must sign the corresponding document containing, among other information, his or her personal details, the prize amount and the tax withholdings as required by law.
